### [What's on the Library Shelves?](#)

[Criminal Justice](#) is a three-volume work edited by Phyllis Gerstenfeld and published by Salem Press that contains, in encyclopedia format, listings about criminal law, criminal procedure, crime, and the administration of criminal justice in the United States. In addition to the alphabetical listing, volume 3 includes a general subject index, as well as separate indexes to court cases, laws, and famous persons. There is another excellent feature of this set, a listing of 72 subject categories with relevant articles enumerated under each. Included are such subject headings as *White-Collar Crime*, *Terrorism*, *Hate Crime*, *Crime Statistics*, *Domestic Violence*, and many others. There are many other features in this set (tables, charts, photographs, etc.) that only serve to enhance what is presented textually. This resource serves as a good general introduction to the field of criminal justice. (REF. 345.75 CRI)

[Stressed Out: Strategies for Living and Working in Corrections](#) (2<sup>nd</sup> ed.) by Gary Cornelius and published by the American Correctional Association looks at the subject of job stress. This resource is different, however, in that it targets a specific group of professionals—those who work as correctional professionals (correctional officers, parole officers, probation officers, counselors, correctional health care staff, juvenile care workers, etc.). Cornelius, with more than twenty-five years of correctional work experience, has revised his original 1994 work to help those in corrections live longer, healthier lives, and work better by managing stress in the workplace.
