The North American Association of Wardens & Superintendents ([NAAWS](#)) in partnership with Correctional Peace Officers ([CPO](#)) foundation have organized a project called "[Make A Smile](#)." They are going into Louisiana and Mississippi to build playgrounds for children of those families who were so horribly affected by Hurricane Katrina. They are especially targeting those

areas where correctional families live. They are going to build two playgrounds. One in the 9th Ward in New Orleans and another will be in the town of Bogalusa, a few miles from Rayburn Correctional Facility.
