### CSAFE Crime Trends

As every HEAT Team member will tell you, Community Crime Trends is the first item on the HEAT Team Meeting Format. Sometimes there may be little to report or perhaps the officer may think his teammates have little use for the information. But exchanging crime trend information is critical.

Very often the law enforcement team member not only reports that crimes occur but they also provide information about suspects, vehicles, methods of operation, dates and times when crimes are occurring, types of property being taken and more. I have never seen an agent or counselor bored because they were getting too much information about crime. As every bookstore will tell you, crime is a best seller.

Also, reporting crime trend information is not a one-way street. Agents and counselors are additional sets of eyes for law enforcement. Their observations about the community, crime and suspects can be very valuable.

### Cambridge CSAFE Team Distributes "Offender Re-Entry Baskets"

The Dorchester County CSAFE Neighborhood Safety Team recently approved the purchase of 25 "Offender Re-Entry Baskets" for individuals being released from the Division of Correction. The planning, purchasing, and distribution of the baskets has been a collaborative effort involving Christine Killmon (DPP), Pat Banks (DPP), Cory

Fink (DJS), Cpl. Antoine Patton (Cambridge PD), and Wendy Hughes (Local Management Board). The funds were made available through a grant awarded by the City of Cambridge. Items in the clothes basket include: a towel, washcloth, soap, deodorant, toothbrush and toothpaste, brush/combs, and other hygiene related products. Wal-Mart gift cards were purchased and included so offenders can purchase other materials that they may need to help aid in the transition back into our communities.

Criteria was established to aid in identifying those eligible participants; including that they reside in Dorchester County, were released from a DOC facility, employment status, and the condition that they be clean from drugs and alcohol. If the pilot phase of the program is a success, the team hopes to add more baskets and expand the criteria in the coming years.

## The "T" in HEAT Stands for Treatment

As I was writing this article, I thought about titling it – "Not your parent's marijuana." However, the implications for this may have a more negative impact than intended. I include this statement because there are ideas from previous generations' use of marijuana that still abound. How familiar does this sound: "it's harmless," "you can't get addicted," and "it takes the edge off."

According to The High Intensity Drug Trafficking Areas (HIDTA) program, marijuana continues to be the most available and frequently abused drug in the Baltimore/Washington area. The significance of this is not the availability but the potency of the domestic plants. A 2004 National Drug Treatment Assessment study reports that in 1974, the average THC content of illicit marijuana was less than 1% while in 2002; the average THC level was more than 6%.

Advanced hydroponics techniques at indoor growth sites are contributing to the increased potency. In 2006, law enforcement identified more than 29 businesses in Maryland and Northern Virginia that sell equipment used in the hydroponics procedures. As public safety officials, we want to familiarize ourselves with magazines and catalogs that sell this equipment, paying special attention to the pictures. Should we come across this type of paraphernalia or recognize the presence of this equipment in someone's home, we could then follow agency policies about how to share this information, promoting collaboration.
